**Marketing & Communications Overview.** Dr. Karl Easttorp and Ms. Melissa Rodriguez presented an overview of marketing and communications to the Board of Trustees.

### **President's Report.** Dr. Hickox reported on the following topics:

- CDL State Grant: WWCC was notified this week that we are a recipient of a state grant consisting of \$135,000 in 2023, \$254,000 in 2024, and \$177,000 in 2025 to support reinstatement of the CDL program to hire instructors, provide student scholarships, and purchase equipment.
- New Student Orientation: 40+ students in attendance today, with additional sessions scheduled next week.
- NWCCU Commission Meeting: Accreditation follow-up meeting to be held January 25, 2023 in Seattle.
- ACT Transforming Lives Awards Dinner: Will be held January 23, 2023 in Olympia. Each nominated student will receive \$250 and the selected winners will receive \$500.
- Scott Grant: The college received notification this week that the annual grant reporting requirement for the MacKenzie Scott gift WWCC received is no longer requested.
- FA Outreach Positions: We are in the process of final interviews for the FA outreach positions that we received funding for through the state along with Big Bend, Columbia Basin, Olympic and Peninsula Colleges and hope to have those filled soon.
- Legislative Luncheon: Wednesday, December 14, 12:00 to 2:00 PM at Columbia Basin College.
- Annual DOC/SBCTC Meeting: Friday, December 2.
- SBCTC Capital Budget Committee: Committee is working on a proposal that would address the backlog of capital requests, while moving towards the goal of having more modest, manageable requests going forward.
- 1<sup>st</sup> Annual President's Holiday Hoopla: Wednesday, December 7, 1:30 to 3:30 PM on the Clarkston campus and Friday, December 9, 2:30 to 4:30 PM on the Walla Walla campus. Trustees are invited to attend and celebrate with our employees.



RE: Final\* Fall Quarter Enrollment

\*This memo contains final enrollment data for Fall Quarter, 2022. Final numbers have not been distributed. However, we do not anticipate any significant changes after their release.

- State supported enrollment for fall quarter is currently reporting 1,564 FTE, which is currently down 113 FTE (7%) from the **close** of fall 2021.
- Contract enrollment is reporting 1,119 FTE, down 158 FTE (12%) from the **close** of fall quarter 2021.
- Fall quarter self-support enrollment is reporting 50 FTE, down nine FTE from the **close** of fall 2021.
- Enrollment for combined fund sources amounts to 2,733 FTE, down 281 FTE or 10% from the close of fall quarter 2021.
- The accompanying page presents a time-series of fall quarter enrollment, showing the total FTE by funding source.

RE: Interim Winter Quarter Enrollment

This memo contains enrollment data reported thus far for Winter Quarter, 2023.

- State supported enrollment for winter quarter is currently reporting 1,495 FTE, which is currently down 77 FTE (4.8%) from the **close** of winter 2022.
- Contract enrollment is reporting 550 FTE, down 530 FTE (50%) from the close of winter quarter 2022.
- Winter quarter self-support enrollment is reporting 46 FTE, up nine FTE from the **close** of winter 2022.
- Enrollment for combined fund sources amounts to 2,091 FTE, down 599 FTE or 22% from the close of winter quarter 2022.
