Board of Trustees Meeting Minutes Community College District No. 20 Walla Walla Community College

The Board of Trustees of Community College District No. 20 met in regular session on Wednesday, December 22, 2021 in the Water & Environmental Center and via Zoom. Mr. Bill Warren called the meeting to order at 9:33 a.m.

Approval of Agenda.

Mr. Hernandez moved and Mr. Burt seconded to approve the agenda for the December 22, 2021 Board of Trustees meeting as presented. *Motion carried.*

Educational Attainment, Philanthropy, and Promise Scholarship Concept. Ms. Jessica Cook, Executive Director of the Foundation presented on the Foundation's work and how it relates to the college engaging in the concept of a promise scholarship. Promise scholarships made a promise to provide tuition-free education that is focused on high-need populations with enhanced outreach and intensive wrap-around support. It was shared that the Foundation's annual fundraising brings in upwards of one million dollars and provides over \$1,200,000 in annual college support, which is increased by \$600,000 annually with the Scott Fund distribution. In looking towards opportunity for growth and future opportunities, the Foundation is poised to continue to grow an equity lens in both fundraising and awarding endeavors while embarking on a comprehensive, large-scale campaign to fund student success and extend efforts to secure federal/state funding on behalf of the college, in addition to providing philanthropic gifts to fund programmatic excellence.

Consent Agenda. A brief discussion ensued which resulted in an amendment to item #5 of the Consent Agenda – 2022 Board of Trustees Meeting Schedule – the December 2022 meeting was changed from December 28 to December 21, 2022.

Mr. Hernandez moved and Ms. Leer seconded that the amended consent agenda items be approved or accepted, as appropriate:
1) November 22, 2021 Board Meeting Minutes, 2) December 1, 2021
Special Board Meeting Minutes, 3) Personnel Update, 4) Interim
Fall Quarter Enrollment Report, and 5) 2022 Board of Trustees
Meeting Schedule. *Motion carried.*

President's Report. Dr. Hickox reported on the following:

- Masking at athletic events continues to be a challenge. Recently at the Crossover Tournament that was held on our campus, attendees were met at the door to ensure masks were being worn by all, however upon entering the stands, roughly 25% of attendees had promptly removed their masks. Rounds were made in the stands to encourage folks to put masks on, however masks were once again removed. This behavior will be revisited during the first league games that will occur in January and at that time we will determine how to move forward. It is important to have fans in attendance and to engage the community, however it is also important to be cognizant of COVID 19 and the challenges each variant brings. The college is entrusted to keep people safe when they are on our campus, so the situation is being monitored closely and the Board will be kept apprised should there be a need for change in policy or restrictions on attendance.
- Work on ctcLink continues as the college moves into User Acceptance Testing (UAT). The latest UAT had only one failure out of 324 tests, which is a testament to the very high quality of information and processes that have been mapped out and input. While there is still a long way to go, our employees are doing a fantastic job making progress.

- WWCC, in partner with the Port of Walla Walla, the City of Walla Walla, the City of College Place, and Walla Walla University, were recently notified that the funding proposal for the EDA Build Back Better grant had not been advanced to the next round. Despite the setback, WWCC is continuing to look for new ways to fund the ideas presented, in addition to developing new ideas in collaboration with those entities and partnerships that were developed as we engaged in the grant application process.
- Initial winter quarter enrollment numbers compared to winter 2021 are down slightly less than 4%, a change from a week ago where we were down about 7%. The trend is moving in the right direction as Enrollment Services and Student Success Center Advisors continue to diligently work through their lists of students. As the start of winter quarter moves closer, due to challenges brought on by the pandemic and ensuing mandates, some flexibility has been built into existing deadlines. We are doing everything we can to reduce barriers faced at entry, and compared to other colleges around the system, we're doing a remarkable job.
- Our first annual report in reference to the MacKenzie Scott funds is due December 24. The report is very narrative in nature and is to include audited financial statements, our operating budget, and a small visual representation of our students. As gathered from the discussions today, a general mention of the college's interest in using Scott funds to pursue the path of a promise scholarship will be inserted in the report.
- Discussion surrounding holding an Educational Attainment Summit with various members of local community Boards of Trustees has been ongoing. The timeline is adjusting somewhat, we are looking into moving it to late January as we secure additional data and determine attendees. WWCC's Board members will need to determine who will be WWCC's representatives.

AHE Update. None.

New Trustee Orientation / Transforming Lives Award. Dr. Hickox discussed the upcoming ACT meetings that will be held on January 24 and 25 in Olympia. At this point, there is not a virtual option available. WWCC's TLA nominee was not selected as a finalist, however all nominees are invited to attend the award ceremony. At this time, Chad, Bill, Tara and Tim have committed to attending.

Board Reports / Remarks. There was discussion on the following items:

- Holding meet and greets with faculty in reference to the tenure process. A decision
 was made to hold an informal meet and greet for faculty involved in the tenure
 process. Walla Walla faculty would be hosted immediately following the January Board
 meeting and Clarkston faculty immediately following the February Board meeting that
 will be held on the Clarkston campus.
- Selection of the January study session topic. It was determined that Ms. Margarita Banderas would be invited to present on the topic of EDI in relation to the college's strategic plan.

• Employee accolades during the pandemic. Options for Trustee engagement included having one or two Trustees attend employee celebrations or have them write notes of thanks to show their appreciation.

New and Unscheduled Business. In order to assist in the selection of study session topics, Trustees were asked to compile a list of suggested study session topics and provide the list to Mr. Warren and Dr. Hickox.

Public Comment. None.

Adjournment. The meeting adjourned at 12:03 p.m.

RE: Winter Quarter Enrollment

The corresponding tab provides an enrollment report for Winter Quarter 2022.

- State-supported enrollment for winter quarter is reporting 1,543 FTE, a decline of 6 FTE (less than .5%) from the **close** of winter 2021.
- Contract enrollment is reporting 785 FTE, a decline of 237 FTE (23%) from the **close** of winter 2021. Corrections education is reporting 550 FTE, down 228 FTE from 778 FTE at the close of last winter. Contract enrollment should increase as correction enrolls more students in the coming weeks.
- Self-support enrollment is reporting 42 FTE, which is up 9 FTE from the **close** of last winter quarter.
- Enrollment in the Bachelors of Applied Science (BAS) programs is reporting 87 FTE, up 22 FTE from 65 FTE at the **close** of last winter quarter.
- Running Start is reporting 216 FTE, down 5 FTE from the **close** of last winter quarter.
- Total enrollment is currently 2370 FTE, down 233 FTE or 8.9% from the close of winter 2021.


