

# Articulation Agreement

## Between Lewis-Clark State College and Walla Walla Community College RN to BSN Track of the BSN Program

This agreement is made between Walla Walla Community College (WWCC) and Lewis-Clark State College (LCSC) to provide a direct transfer agreement for WWCC nursing graduates who wish to enter LCSC's RN to BSN Track. *This agreement will be reviewed and updated annually as needed.*

Under this agreement Lewis-Clark State College agrees to:

1. Accept WWCC **Associate in Nursing Direct Transfer Agreement/Major Related Program (DTA/MRP)** graduates who meet the LCSC RN to BSN Track admission requirements as outlined below:
  - Admission to LCSC, including submission of official transcripts for academic work from all colleges and universities attended
  - Completion of prerequisite coursework (satisfied by the Associate in Nursing DTA/MRP degree).
  - Completion of all LCSC General Education Core requirements with a 2.0 overall GPA (satisfied by the Associate in Nursing DTA/MRP degree).
  - Compliance with other RN to BSN Track admission criteria such as GPA, immunization requirements, background check, and performance standards detailed in current year RN to BSN application
  - Evidence of NCLEX licensure within 6 months of admission.
2. Upon passage of the NCLEX-RN exam, WWCC nursing graduates with the **Associate in Nursing DTA/MRP** degree will be conferred senior (90 credits) standing at LCSC.
3. Students transferring to LCSC from WWCC who have completed an Associate in Nursing (DTA/MRP), will be identified as "core complete."
4. Summary of transfer credits:

120 semester credits required for LCSC BSN degree

90 semester credits (minimum) accepted upon transfer of Associate in Nursing DTA/MRP  
\*12 escrow credits (\$10/credit) based on current, unencumbered RN license  
24 semester credits of upper division coursework at LCSC remaining for the BSN degree
5. Provide enrollment opportunities each semester for qualified WWCC graduates.
6. Communicate regularly with WWCC representatives including the Director of Nursing Education to discuss changes in the LCSC RN to BSN requirements which may impact or alter this agreement.

\*May need to purchase up to 12 escrow credits to meet the 36 Upper Division Credits for LCSC. Each student will be evaluated on an individual basis.

Under this agreement, WWCC agrees to:

1. Provide information and tools, including degree worksheets and brochures about the LCSC RN to BSN Track onsite and on the Nursing Program's websites.
2. Provide student information sessions and invite LCSC representatives to attend student career fairs or other events where students are seeking information about academic progression opportunities.
3. Communicate with LCSC representatives including the Nursing & Health Science Division Chair to discuss changes in the WWCC program which might impact or alter this agreement.
