The FAFSA® can be submitted at <a href="www.studentaid.gov">www.studentaid.gov</a>.</li> <li>WWCC's school code is 005006.</li> <li>□ Complete the WWCC Financial Aid Information Form for the 2024-25 school year (recommended for all)</li> <li>□ Check your email regularly for communications from the Department of Education (ED) and WWCC. We send notices regarding additional documentation that may be required and awards.</li> <li>○ If you are selected for Verification, you will be required to submit additional documentation. Checklist for DREAMers & DACA students (students not eligible to file a FAFSA®):

The following items are required to receive loans:
<ul> <li>Loans are awarded in an offered status – you must <u>accept</u> them through your ctcLink portal.</li> <li>Master Promissory Note (<u>www.studentaid.gov</u>) (valid for 10 years, cannot expire anytime during the academic year)</li> </ul>
<ul> <li>Loan Entrance Counseling (<u>www.studentaid.gov</u>) (once completed, include us on your list of schools to notify)</li> </ul>
<ul> <li>An additional/late loan request can be submitted. Forms are available at the Financial Aid Office.</li> <li>Additional/late requests will be processed at a later date.</li> </ul>
☐ The Financial Aid Office may request additional documentation to verify information provided in your
application.
