SUBJECT: Appointment of Hearings Officer

At the Board's request, as a follow-up to the November 22, 2021 Board of Trustees meeting, I have contacted the Office of Administrative Hearings (OAH) to inquire about the appointment of a Hearing Officer in the matter of a tenured faculty dismissal.

The OAH, an agency of the State of Washington, was established in 1981 to hold fair and impartial hearings for people who have a dispute with a state or local agency. The purpose of OAH is to promote public trust and confidence in the hearing process. The OAH employs permanent, temporary and pro tem administrative law judges (ALJs) who preside over administrative hearings and issue written orders and/or recommended findings of fact. The hearings comply with all requirements of the Administrative Procedures Act and state ethics laws. WWCC has in place a Memorandum of Understanding with OAH for the purpose of engaging the appointment of a hearing officer when necessary. I have attached an OAH Overview and flow chart of the hearing process.

In accordance with Article 35.4 C of the collective bargaining agreement between the Board of Trustees and the WWCC Association for Higher Education, on behalf of the Board, I consulted with AHE President Jim Peitersen. He is aware of the MOU with OAH and has expressed no objections.







**Why we hold hearings:** So that citizens and businesses who disagree with decisions made by state and some local government agencies have the opportunity to be heard. The Administrative Law Judge presiding over the hearing issues a written order deciding whether to affirm, modify or reverse the agency decision.


